1.0 PURPOSE

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote sustainable partnerships and mutual understanding between the Rabindra Bharati University on behalf of the Department of Library and Information Science, Faculty of Arts on its Emerald Bower Campus, 56A, B. T. Road, Kolkata 700050 (hereinafter referred to as "RBU") in the West Bengal, India and Vidyasagar College For Women, under University of Calcutta, at 39, Sankar Ghosh Lane, Kolkata 700006 (hereinafter referred to as "VCFW in Kolkata, West Bengal, India, Both RBU and VCFW may be referred to individually as the "party" or collectively as the "parties".

2.0 SCOPE OF ACTIVITIES

RBU and VCFW aim to undertake cooperation in areas that may include, but are not restricted to, the following:

a) Resource Sharing Activities for research and study

b) Internship program in Library of VCFW, cooperation with the students of Department of Library and Information Science, RBU.

c) Library Professional /Technical assistance

3.0 ACTIVITY AGREEMENTS

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following:

a) Elaboration of the responsibilities of each institution for the agreed upon activity

b) Specific schedules for the activity, Library of VCFW will be take 2 interns at a time for the period of 3 month each.

c) Budgets and sources of finances for the activity will be provided by Library, VCFW.

d) Initially VCFW provided TA/DA @ Rs. 2000 / month per intern initially; it may be revised time to time.

e) The internship program will continue whole year with three months intervals.

f) VCFW provided Internship Completion Certificate for each successful intern.

g) Any other activities, like seminar, hands on workshop, conference may be organized jointly.

4.0 COORDINATORS

Coordinators shall be named by each institution to serve as liaisons for implementing this MOU. All activities conducted under the auspices of this MOU must have the endorsement of the coordinators. At RBU, the coordinator will be **Dr. Sudip Ranjan Hatua**, Head of the department, Department of Library and Information Science of RBU and at VCFW, the coordinator will be **Dr. Sukanta Kumar Patra**, Librarian of VCFW. Coordinators shall notify their counterparts should a new person be named to the position.

5.0 RENEWAL, TERMINATION AND AMENDMENT

- 5.1 This MOU shall remain in force for a period of five years from the date of the last signature.

 This MOU may be extended by the written consent of the parties.
- 5.2 This MOU may be terminated by either party giving written notice to the other party at least 180 days in advance of the stated termination date. Termination of this MOU shall not

affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.

5.3 This MOU may be amended only by the written consent of the parties.
