Webinar on Copyright Law under IPR Brief Description of the Webinar

The webinar on "Copyright Law under Intellectual Property Rights (IPR)" was organized by Prafulla Chandra College in collaboration with Vidyasagar College for Women, held online in google meet platform. The invited lecture was delivered by Mr. Abhigyan Mazumder, Advocate at the Calcutta High Court. The event took place on 11/01/2023 around 11:30 am in the morning. The presentation of the speaker was shared on the Google meet screen by Prof. Angshuman Mukhopadhyay. About 15 participants attended the webinar.

The key points covered were brief Introduction to Intellectual Property (IP). Mr. Mazumder began by providing an overview of intellectual property and its significance. He emphasized that IP encompasses intangible creations of the human intellect, including copyrights, patents, trademarks, and other related rights. The lecture delved into the concept of copyrights. Copyright is a legal term that grants creators exclusive rights over their literary and artistic works. These rights allow creators to control the use, reproduction, and distribution of their works.

Mr. Mazumder discussed related rights, which include rights granted to communicators of works to the public. These rights cover performers and broadcasting organizations. The lecture also touched upon patents, which provide an exclusive right to inventors for their inventions. A patent grants a limited monopoly, allowing inventors to prevent others from manufacturing, using, or selling their patented products or processes. Mr. Mazumder also explained the concept of Trademarks which serve as distinctive signs identifying specific goods or services produced by a particular person or enterprise.

The webinar provided valuable insights into copyright law and its role within the broader framework of intellectual property rights. The faculties of both the colleges

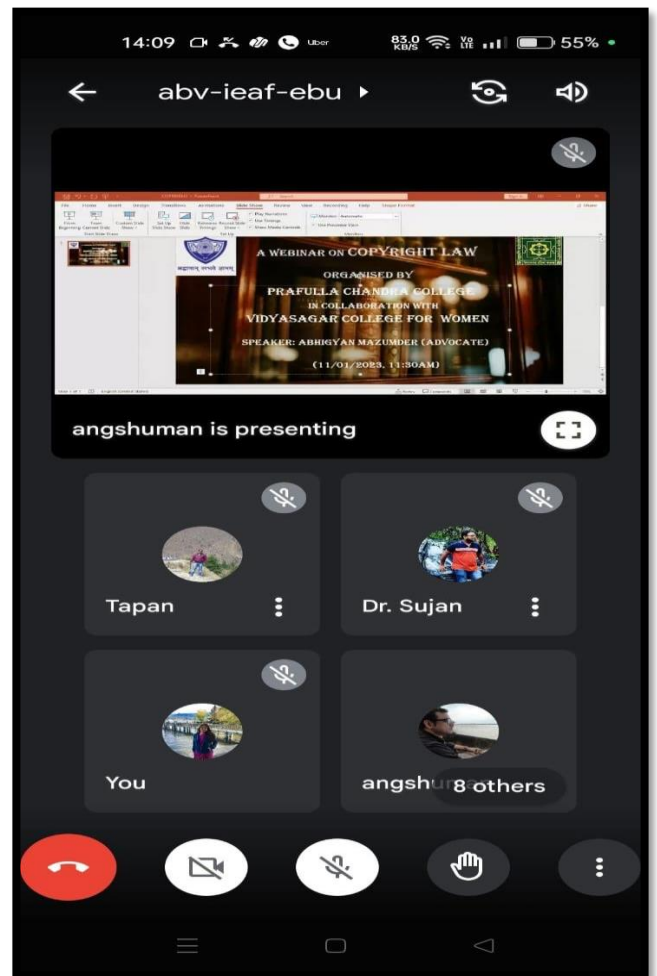
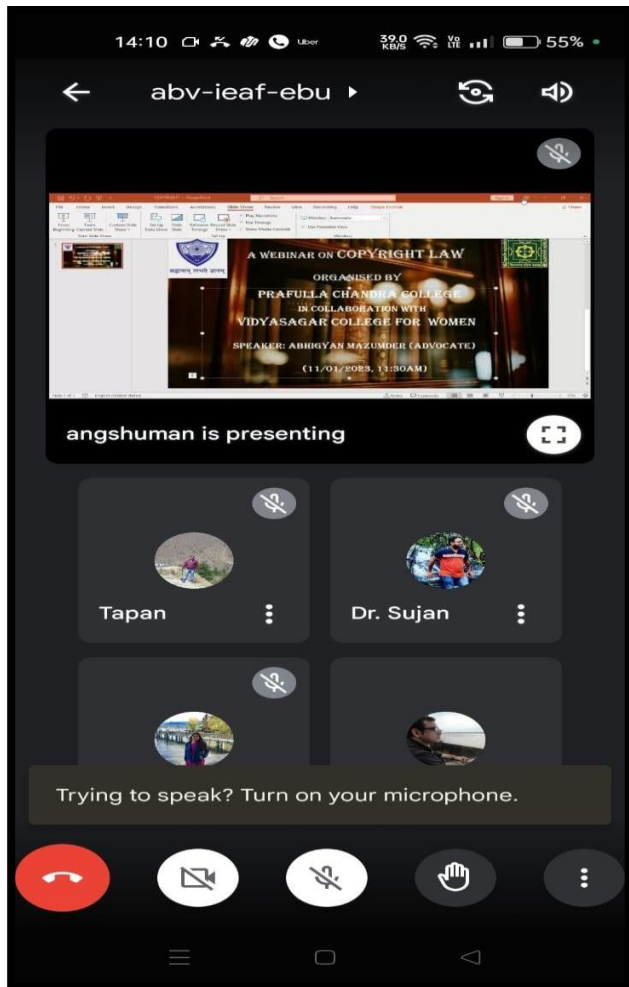
