# 1.1 - Curriculum Planning and Implementation

- 1.1.1 Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words
  - College prospectus having all information about its administration, faculties, course -structure and related data and, curriculum, is distributed among newly admitted students at the beginning of academic session to facilitate transparency and seamless flow of information among stakeholders. 2)
     A College academic calendar, listing all probable dates of examinations and, other academic, co-curricular and extra-curricular events, is prepared in accordance with university academic calendar, at the beginning of academic session. 3) Departmental meetings are convened by all departments at frequent intervals, to discuss departmental issues including assigning of topics to be taught by each faculty. Number of classes required for completing each topic, is also decided in such meetings; most of the departments maintain a meeting-minutes book to preserve all information about the department. Each faculty also records her/his academic and administrative activities performed, in academic diaries which are duly signed by the concerned HOD and the principal.
  - 4) Routine committee of the College provides a class-schedule for all departments; due attention is paid to the fact that classes for Core Courses, Generic Elective papers, Skill Enhancement Courses, and others are allotted according to the requirement of the syllabi prescribed by the University of Calcutta for the concerned subject for each semester. Departmental Heads allocate classes to departmental faculties and a copy of the final routine is handed over to the Principal for ready reference. 5) Teachers prepare their

lectures according to the syllabus allotted, often employing innovative modes to deliver their lectures. 6) College has a very rich central library with open access system with reading facilities for both students and teachers; many departments have rich Departmental libraries for the benefit of students. Many Journals (Science and arts) have been subscribed by our college. 7) Different classroom teaching methods based on the needs of different subjects are regularly used for the delivery of the curriculum :- a) Chalk and Blackboard method. b) ICT-enabled teaching-learning method and virtual class for visual learning. c) Use of Scientific models and charts for effective delivery of lecture. d) Distribution of class notes by teachers. e) Students Seminar conducted by all Departments. f) Proper and adequate instrumentation facility is given to the students for their practical classes. g) Need based survey programmes, field works and educational excursions are carried by some of the departments. h) Each department regularly organizes Seminars and special talks by resource persons for advanced learning. Regular class tests, Mid-term examinations, assessment in practical classes, viva-voce, are done to keep track of the academic improvement of the students. Departments maintain the detailed record of the classes, assessments, project reports etc. However, it must be noted that all the afore-stated modes of lecture delivery were followed till the 15th of March, 2020 when a nation-wide lockdown was declared by the Govt. to contain the rapid surge of Covid pandemic. Hence, classes were conducted in online mode by the teachers, records of which have been meticulously maintained by all departments. Examinations were also held on online mode.

#### Feedback Obtained

Since feedback plays an important role in the Teaching-Learning process, students' feedback on teaching is taken annually from the outgoing 6th Semester students. A questionnaire for obtaining feedback on different aspects of the teaching-learning process is hosted online on college website. The students are instructed to click the given link and provide their feedback with absolute sincerity and honesty. They may choose to provide feedback anonymously, if they so desire. The college authority analyses the data thus obtained from the feedback to re-evaluate teaching methods of Faculty members. Teachers are informed by the principal about the result of feedback in one on one correspondence so that they can improve their teaching-learning process. The feedback obtained helps in effecting improvements in the teaching-learning process and classroom management as well. Other means of obtaining 360 degree feedback are as follows: 1. Management Feedback, 2. Alumni Feedback, 3. Course Feedback, 4. Parental Feedback, 5. Faculty feedback, 6. Supporting Staff feedback, 7. Institutional Feedback, 8. Feedback on Library Services, 9. Excursion feedback, 10. Assignment Feedback, 11. Project Feedback In addition to these, following measures are taken: 1. Most Departments hold parentteacher meetings to melt the ice between stakeholders of the college , facilitating seamless flow of relevant information, clarification of queries and clearance of doubts. 2. There is a Grievance Redressal Cell which holds

periodic meetings with the students a Grievance Box has been placed in the college premises to enable any dissenting student to post her grievances, incognito if she thus wishes. The feedback process has indeed opened and strengthened a transparent communication channel between students and teachers. Although not formally a mentoring system, the teachers provide academic assistance beyond class hours, provide notes, furnish relevant video links, share power point presentations, discuss topics in Google classrooms and, organize question-answer sessions to iron out any doubt students might have on any topic from their syllabi. Students are also sent to the personal councillor (College appointed) for their mental well-being, in case the teacher detects any untoward behaviour of any student. Parent-teacher meeting is convened yearly to intimate the weakness of the ward to the respective guardian. Records to this effect are maintained by the respective departments. Responsibilities and work-hours of teachers have ceased to exist with the introduction of online mode of teaching as dissemination of information and doubt clearing sessions are conducted on virtual mode queries, doubts are clarified through texts and materials are often shared through Google classrooms throughout the day. Students also communicate with teachers over phone, if so required, for addressing any academic or personal issue(s).

#### 7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

1) Planting of Saplings: A programme was organised by Green Club on 8.11.2019 in the New Building Campus. Students of NSS Unit planted saplings and were given responsibility to look after them. 2) A rally organised by Green Club To save Mother Earth from pollution in Dec. 2019. Students of the Department of Geography and NSS Unit of the college participated in the rally. The purpose of the rally was to create an awareness among local people (surrounding the college) regarding Environmental pollution and how we can mitigate that. 3) On September 05, 2020 Green Club and NSS jointly organised a youth sensitization virtual event on "Global Warming." A student named Prarthana Das of the Department of Geography presented on Amphan (the storm that lashed Bengal). The title of her presentation was "Amphan-An Overview, Highlighting Preventive Measures." 4) An Inter-College Online competition was organised by NSS and Green Club for students in October 2020. Events of the competition were a) Slogan writing b) Essay c) Photography d) Painting competitions. No. of students participated were Painting- 93, Slogan Writing- 72, Essay-72 and Photography-155. Last date of virtual submission was October 21, 2020. Winners were intimated through email. Participation Certificates were distributed to

all. It was a successful one. 5) On January 28-29, 2020 Green Club organised Poster Competition on contemporary issues related to Nature. Problems, perspectives and possible solutions were highlighted in the posters, all innovatively designed by students. Green medals were awarded to winners and certificates were distributed to all participants.

#### 7.2 – Best Practices

#### 7.2.1 – Describe at least two institutional best practices

Best Practice 1 Title of the Practice Successful Implementation of Online Teaching-Learning during the Pandemic The Objective: During the pandemic and subsequent nationwide lockdown since March 2020, our college successfully implemented online classes. Principal and Teachers met over virtual platform to discuss the modalities of conducting online classes. In the virtual meet, the need to maximise the use of educational technology for online tutoring was emphasised. It was soon evident that these classes offered flexibility and a variety of academic opportunities to our students. Teachers assisted students with soft copies of learning material. Online learning offered teachers an efficient way to deliver lessons to students. Tools such as PDFs, audios, videos could be used by teachers as part of their lesson plans. The Context: The Pandemic triggered new ways of learning. Digital learning emerged as a necessary resource for students. Students recognised and appreciated the benefits of online classes. It offered scheduling flexibility. Conducting University examination online was also part of the agenda. The Practice: Students met Professors on a virtual platform during virtual college/class hours. Synchronous online classes maintained pre scheduled, set class times, as per routine, where Professors instructed students over Google Meet, Zoom or Video Conferencing Service. During online classes students interacted with professors and peers. Teachers conducted online classes even on government holidays to make up for lost time. Evidence of Success: Online classes were held as per master routine but often such classes ran asynchronously to provide extra classes to learners. Teachers made maximum use of online resources. Teachers of our college now, have emerged as more efficient educators. Online lectures could be recorded and saved for future reference. Students saved time and money by eliminating a commute on a daily basis. Digital study materials were distributed before and after online classes over emails, whats app. Teachers regularly uploaded study materials on Google classroom. With the ability to study anywhere from any location, students got the environment that best suited them. Since online classes could be taken from home or location of choice, improved student attendance was detected. Students got a solo learning experience as they were not distracted by large groups in classrooms. Students reported an enjoyable learning experience. In case of intermittent internet facility, some teachers circulated pre-recorded audio lectures to students. All University Examination could be smoothly conducted online without much technical glitch. Problems Encountered and Resources Required: Unreliable, intermittent, low-speed internet connection in far flung localities created a digital divide. Practical classes of Laboratory based departments encountered major issues which could not be conducted online. Students did not have access to laboratories. It is important for college to invest in training teachers with the latest technology updates so that they can conduct online classes seamlessly. Health hazards of having students spending hours staring at the digital screen, surfaced. Digital eye strain was a consistent problem amongst teachers and students. A good solution to this would be to give students plenty of breaks from the screen to refresh their mind. The pre-existing counselling and mentoring system of students need to be strengthened to help students cope with mental health issues. Further, college will have to tweak the current academic calendar so that we can cover the syllabus within the curtailed semester period. Best Practice II Title of the Practice: Establishing

Sanitisation and Covid Safety Protocols on Campus The Objective: To curb the spread of Covid infection it was absolutely necessary to reinforce the everyday precautions during the pandemic. Though campus was closed, students occasionally had to visit campus to pay admission fees or for collecting marksheets. Social distancing was maintained to slow down the spread of a highly contagious disease and to reduce close contact among students while standing in a queue at the college premises. The Context: Our college adhered to the recommendations set forth by government, implementing every measure needed to keep students safe while on campus. College campus, including classrooms, staff rooms and office was regularly sanitised to ensure a Covid free campus. Social distancing was adhered to and alternate dates for fees/marksheet collection were declared to limit large group of students from coming together. The Practice: To curb the contraction of Covid, it was mandatory for students, teachers and staff members to wear masks. No one was allowed entry on campus without a mask. High-touch surfaces like drinking water facility was disinfected. Soap, water, hand sanitiser were readily available and sanitising dispensing machines were installed. Frequently touched surfaces and objects were cleaned meticulously. Students and staff who felt sick were advised to stay at home. All who entered campus were initially screened with a thermal gun upon arrival. Evidence of Success: Not a single Covid case was reported on campus. On the day of non-teaching recruitment, strict Covid safety protocols were implemented. As several candidates reported for virtual interview on campus full body sanitiser machine was installed. Maintenance of safety protocols on campus helped students cope with fears and anxieties surrounding the disease. The safety measures helped to cultivate compassion and increase resilience while building a more safer and more caring community. Major events like Independence Day Celebration, Vidyasagar Bicentenary Celebration, seminars all were held on a virtual platform. Problems Encountered and Resources Required: Often students gathered in groups and it was difficult to observe social distancing. Maintaining safe college operations or reopening college campus after a closure requires many considerations, but if done well, our college may contribute in the promotion of public health. College should provide better water, sanitation and waste management facilities in the pandemic era. Collegeshould strive for an eco-friendly campus and implement decontamination procedures wherever applicable. Resources would be required to drastically increase hygiene and to daily disinfect campus premises.

#### 7.3 – Institutional Distinctiveness

Year-long bicentenary celebration of Pandit Ishwar Chandra Vidyasagar was a flagship programme of the institution. The Bengal luminary's bicentenary, on whom our institution is named, did seek to achieve a viable diffusion of the values infused in the thinking and work of Vidyasagar in contemporary society. The bicentenary celebration was an act of homage to the multifaceted genius of this pillar of the Bengal Renaissance. Events that outlined the grand celebrations, engaged with the literary, social, educational, scientific, and philosophical dimensions of his works. Ranging from his commitment and intellectual investment in projects of social reform and women's empowerment, the year-long celebrations highlighted Vidyasagar as the pioneer in transforming the crusade against child marriage and other atrocities against women in society. The celebrations at our institution brought to light the fillip he gave to scientific and rational enquiry in his educational and social

stretches beyond the pales of his own land, Bengal, and touches the hem and shore of every nook in India, before exfoliating further to achieve truly international proportions. On 26 September, 2019, Sri Anup Motilal delivered the Vidyasagar Memorial Lecture on "Vidyasagar and Re -Creation of Social Values.". As someone who believed in the crucial role of nurture whether of the human (as in children) or of nature, the repository of tenderness and inspiration, Vidyasagar's views on these matters and his expeditious interventions, trying to make thinking a reality, figured prominently in the deliberations at our bicentenary webinar held again on September 26, 2020. Sri Jawhar Sircar and Dr. Krishna Ray were the eminent speakers of the Vidyasagar memorial lectures. An Inter College Online Competition featuring short story writing, songs, dance, poster and debate were held to commemorate the grand event. Contestants recorded videos and submitted entries. Focuswas on Vidyasagar's greatest legacy, his unflinching resolve to transform the plight of Indian women and his continuous relevance in today's society. The holistic impact of this great son of Bengal on life and letters in the contemporary world- was debated, argued and reinforced at our offline and virtual events, giving us new insights into the great man's continuing relevance and contribution to humanity, our nation, our time and our way of life. This meaningful, relevant exchange of ideas on the life and works of such a great, compassionate reformist wasthen gathered up and published in the impressive bicentenary volume "Suvakori" (with ISBN 978-93-81037-90-4) on September 26, 2020, thus recording these ideas for academic posterity and advanced research.
